- D Photocopy of Travel Stamps Outside the Country.
- **2 Passport size picture:** With Collar. White background. No white-colored shirt/blouse. NO accessories. Neutral faceexpression. DO NOT STAPLE!
- **Photocopy of Latest PSA Birth certificate.** Colored Photocopy. Issued within present year prior to application.
- D Photocopy of Latest PSA Marriage Certificate. Colored Photocopy. Issued within present year prior to application.
- **Copy of Bank Certificate.** \*Available Fund must reflect At least Php 300,000.00 (*if applicable*)
- **Copy of Bank Statement.** \*At least 6 months transaction history (*if applicable*)
- **Copy of Credit Card Statements and Limits** (*if applicable*)
- Additional Documents: Copy of Properties. Land Title, Car Registration, etc. (*if applicable*)
